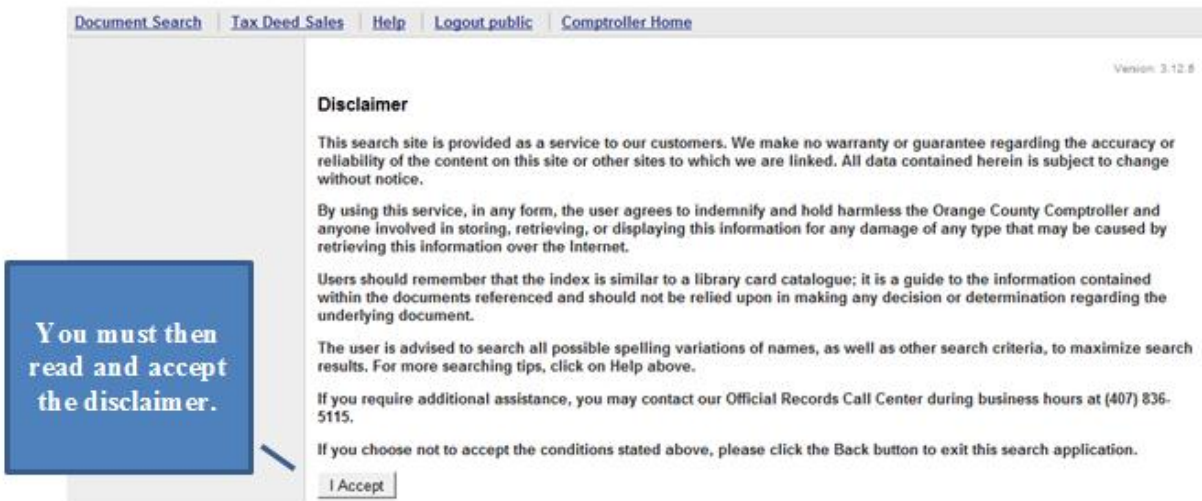
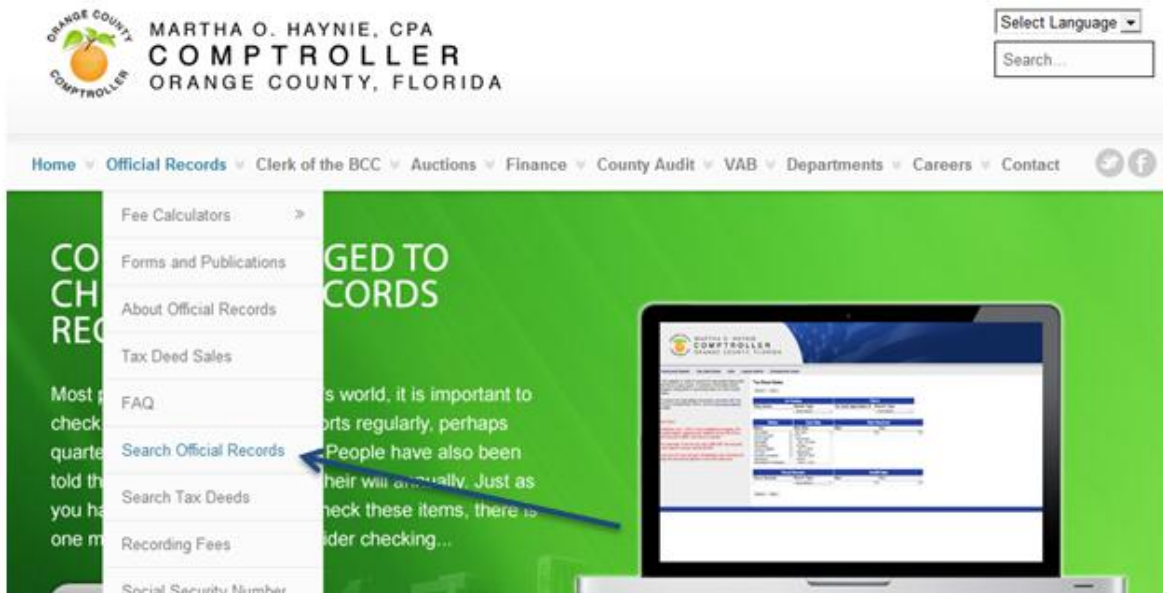


Search Official Records for Domestic Partnership Registry (DPR) & HELP Affidavits

From the Comptroller's homepage (www.occompt.com), place your cursor over the words "Official Records" on the header row and choose "Search Official Records" from the dropdown menu.





Documents Proofed through
 March 15, 2013

Advanced Search Tab: Fields work only on documents recorded after 6/1/2008 and must be an exact match.

Images on Web: Index data is complete back to 1843. When not prohibited by law, document images are viewable from 1843 to present.

The system is driven by document number; not by book and page number. Every document number is accounted for.

Alphabetic Books: Type the letter in the Book field. For example, if you are searching for book A, page 20, type "a" in the Book field, and "20" in the Page field.

Highlight "Affidavit".

There are three fields used for doing name searches: Grantor, Grantee, and Either Party. The Grantor and Grantee fields will search only those fields. The Either Party field will search for names that appear in either the Grantor **OR** the Grantee field. The name must be entered Last Name First.

Example: Smith Sally

By entering the name in the "Either Party" box, you will get results from either Grantor or Grantee searches.

ORANGE COUNTY DOMESTIC PARTNERSHIP REGISTRATION AFFIDAVIT
 Per Orange County Code Chapter 22 Article V and City of Orlando Code Chapter 57 Article VI

We, the undersigned co-applicants, do declare that we meet the requirements of Orange County Code Chapter 22 Article V and agree to the following statements:

| CC | BB | I am at least eighteen (18) years old and competent to contract. |
| CC | BB | I am not currently married under Florida law, nor am I a partner in a domestic partnership relationship or a member of civil union with anyone other than the co-applicant. |
| CC | BB | I am not related to my co-applicant by blood as defined in Florida law. |
| CC | BB | I consider myself to be a member of the immediate family of the co-applicant, and I am jointly responsible for maintaining and supporting the registered domestic partnership. |
| CC | BB | I reside in a mutual residence with the co-applicant. |
| CC | BB | I will notify the County Comptroller, in writing, if the terms of the Domestic Partnership Registration are no longer applicable or if one of the domestic partners wishes to terminate the domestic partnership. |
| CC | BB | I acknowledge that registration under this ordinance will grant to the co-applicant healthcare facility visitation rights, healthcare decisions, funeral/burial decisions, correctional facility visitation rights, emergency notification of family members, pre-need guardian designation rights, and educational participation rights, as reflected in the City of Orlando DPR Ordinance under Section 57.84. |
| CC | BB | In the event that I have been determined to be incapacitated to provide informed consent for medical treatment and surgical and diagnostic procedures, I designate the co-applicant as my surrogate for health care decisions. I fully understand that this designation will permit the co-applicant to make health care decisions and to provide, withhold, or withdraw consent on my behalf; to apply for public benefits to defray the cost of health care; and to authorize my admission to or transfer from a health care facility. I further affirm that this designation is not being made as a condition of treatment or admission to a health care facility. |
| CC | BB | I designate the co-applicant as my agent to direct the disposition of my body for funeral and burial. |
