RESOLUTION

of the

ORANGE COUNTY BOARD OF COUNTY COMMISSIONERS

regarding

AUTHORIZING CONVEYANCE OF COUNTY PROPERTY TO FLORIDA DEPARTMENT OF TRANSPORTATION FOR S. R. 500/441 IMPROVEMENT

Resolution No. 2002-M-38

WHEREAS, the State of Florida Department of Transportation (FDOT) proposes to construct or improve State Road No. 500/441, Section No. 75010-2542, in Orange County, Florida in the area from the Orange/Osceola County line to Phyllis Drive where it intersects the South Orange Blossom Trail; and

WHEREAS, it is necessary that certain lands now owned by Orange County be acquired by the State of Florida Department of Transportation to allow the FDOT to construct said road improvements in accordance with state law; and

WHEREAS, County use of the deeded lands can be accommodated under FDOT ownership so said property does not need to be in County ownership; and

WHEREAS, the State of Florida Department of Transportation has made application to said County to execute and deliver to the State of Florida Department of Transportation a deed in favor of the State of Florida Department of Transportation, conveying all rights, title and interest that said county has in and to said lands required for transportation purposes, and said request having been duly considered.

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners of Orange County, that:

- (1) The application of the State of Florida Department of Transportation for a deed is for transportation purposes which are in the public interest and for a public purpose, and the land described on the deed attached as Exhibit A to this

Resolution can be accommodated in accordance with said deed. It is a specific condition of this conveyance that County general utility and drainage be accommodated and permitted in the area conveyed and that if such utilities must be relocated now or in the future, that such relocation shall be at the cost and expense of the State of Florida, Department of Transportation.

- (2) That a deed in substantially the form attached to this Resolution in favor of the State of Florida Department of Transportation conveying all right, title and interest of Orange County in and to said lands is authorized by the Board of County Commissioners.
- (3) That a certified copy of this resolution and the executed deed be forwarded forthwith to the State of Florida Department of Transportation at 719 South Woodland Blvd., Deland Florida, 32720.
