RESOLUTION

of the
ORANGE COUNTY BOARD OF COUNTY COMMISSIONERS
regarding
**ADOPTION OF FEES FOR APPLICANTS SEEKING
TO QUALIFY FOR REDUCED WATER AND
WASTEWATER CAPITAL CHARGES AND PROVIDING FOR
PERIODIC MONITORING FEES**

Resolution No. 2005- M-56

WHEREAS, the Board of County Commissioners adopted an ordinance amending sections 37-279(e) and (f) and 37-305(e) and (f), Orange County Code, relating to water and wastewater capital charges; and

WHEREAS, the referenced amended ordinance provides for a mechanism where property owners developing commercial property may present an engineering study to staff of the Orange County Utilities Department seeking to justify reduced water or wastewater capital charges; and

WHEREAS, Orange County Utilities staff will be required to review the engineering study submitted by a property owner seeking to qualify under the amended subsections of Chapter 37, Orange County Code; and

WHEREAS, the final determination of whether or not an individual qualifies for a reduced charge will be made by the Utilities Capital Charge Appeals Board ("UCCAB"); and

WHEREAS, the amount of County staff devoted to the review of the study and review by the UCCAB is expected to be significant; and

WHEREAS, it is appropriate that the applicant for the reduced water and wastewater capital facility charges should absorb the costs of this review of the engineering study and determination by the UCCAB and for periodic monitoring of water and wastewater use; and

WHEREAS, this Board has determined that fair fees for the review of the engineering study and determination by the UCCAB are set forth below.


**THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS
OF ORANGE COUNTY AS FOLLOWS:**

1. Section 1. Upon adoption of the Ordinance on December 20, 2005, amending subsections 37-279(e) and (f) and 37-305(e) and (f), Orange County Code, the fees set forth on Exhibit A attached to this Resolution shall be applied in conducting the technical review of the engineering study and the determination of qualification by an applicant for reduced water and wastewater capital charges by the UCCAB.


2. Section 2. This Resolution shall take effect immediately upon adoption.

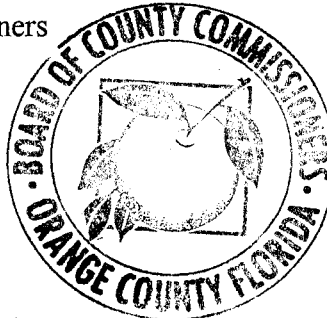
