RESOLUTION ADOPTING A SPECIFIC SERVICE CHARGE  
FOR WASTEWATER PUMP STATION  
SUPERVISORY CONTROL AND DATA ACQUISITION (SCADA)

WHEREAS, the Board of County Commissioners of Orange County establishes and collects rates, fees and charges for its Wastewater System pursuant to its home rule powers granted to the County by the Florida Constitution, the Orange County Charter, Chapter 125 of Florida Statutes and any other applicable statutory authority.

WHEREAS, the Board of County Commissioners last adopted a revised Orange County Wastewater and Pollution Control Charge Schedule on May 14, 1996, and amended the Orange County Wastewater and Pollution Control Charge Schedule, on several occasions since, notwithstanding automatic annual adjustments to the same.

WHEREAS, the Board of County Commissioners has analyzed and caused to be prepared the cost of administering the Wastewater Pump Station SCADA program.

WHEREAS, the Board of County Commissioners now desires to adopt the recommendation for charges associated with the implementation of SCADA system for new Wastewater Pump Stations.

BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF ORANGE COUNTY:

Section 1. Revised Wastewater and Pollution Control Charge Schedule. The Board of County Commissioners hereby adopts the Orange County Wastewater and Pollution Control Charge Schedule for Wastewater Pump Station SCADA systems attached hereto and incorporated in this Resolution as Exhibit "A". The attached schedule hereby adds to the presently existing fee schedule. The remaining portions of the existing Orange County Wastewater and Pollution Control Charge Schedule adopted May 14, 1996, in Resolution No. 96-S-03, and the existing amendments to the Orange County Wastewater and Pollution Control Charge Schedule, shall remain in full force and effect.

Section 2. Severability and Provisions. If any provisions of this Resolution or the application thereof to any person or circumstance are held invalid, the invalidity shall not affect other provisions or applications of this Resolution, which can be given effect without the invalid provisions, or applications, and to this end the provisions of this Resolution are declared severable.

Section 3. Effective Date. This Resolution shall take effect April 15, 2007 for all new subdivision plan submittals.
