# RESOLUTION

*of the*  
**ORANGE COUNTY BOARD OF COUNTY COMMISSIONERS**  
*Regarding*  
**CERTAIN SERVICES FEES CHARGED BY  
ORANGE COUNTY FIRE RESCUE DEPARTMENT**

Resolution No. 2018- M-19

**WHEREAS**, the Board of County Commissioners has authority by law to enact and, from time to time, amend fees charged by the Orange County Fire Rescue Department for services rendered to the public; and

**WHEREAS**, Orange County can legally charge a fee for such services that captures the reasonable cost associated with administrative, personal services, operating, capital, and overhead to provide that service; and

**WHEREAS**, the Orange County Fire Rescue Department has recommended a change in some fee amounts in order to make the fee imposition fairly reflect the actual cost of service provision; and

**WHEREAS**, the County's Office of Management and Budget concurs with the recommendation that the Board approve the revisions to the schedule of fees as to services rendered.

**NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF ORANGE COUNTY:**

**Section 1.** The Board of County Commissioners of Orange County hereby approves the schedule of fees attached hereto as "Exhibit A" and thereby amends the existing fee schedule and establishes new fees to become effective immediately.

**Section 2.** This Resolution shall take effect immediately, and the rates established hereby shall take effect on October 1, 2018, or as soon afterward as is practical.

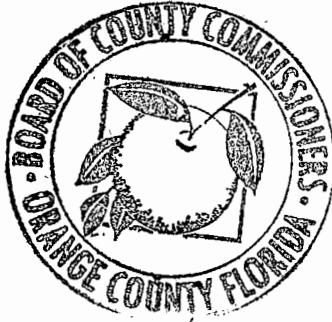
