

RESOLUTION NO. 86-M-04

A RESOLUTION APPROVING RIGHT-OF-WAY
RESERVATION MAP; PROVIDING AN EFFECTIVE
DATE.

WHEREAS, the Board of County Commissioners of Orange
County, Florida ("Board") has received from the
Orlando/Orange County Expressway Authority ("Authority") a
map of reservation delineating the limits of proposed
right-of-way for the construction by the Authority of an
extension of the expressway system; and

WHEREAS, the Authority has been created under Chapter
348, Florida Statutes, and has eminent domain authority pur-
suant to Chapter 74, Florida Statutes; and

WHEREAS, the Board, as the governing body of the County
in which this right-of-way is located, has published notice
that a public hearing would be held on this date to consider
approval of this map; and

WHEREAS, the Board has provided first-class mail notice
of this public hearing to all affected property owners of
record, as recorded in the property appraiser's office,
according to the list of property owners provided by the
Authority, at least twenty (20) days prior to the date of
this hearing; and

WHEREAS, the Board has notified all local governmental
entities in which the described right-of-way would be located
by first-class mail at least twenty (20) days prior to this
hearing date; and

WHEREAS, the Board adopts this Resolution for the purpose
of approving this map* of reservation in accordance with and
pursuant to Section 337.241, Florida Statutes.

THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMIS-
SIONERS OF ORANGE COUNTY, FLORIDA:

Section 1. Approval of Map of Right-of-Way Reservation.

The Board hereby approves the map of right-of-way reservation
attached to this Resolution as Exhibit A and incorporated
here by reference.
