A RESOLUTION DISSOLVING THE LAKE MAITLAND-MINNEHAHA MUNICIPAL SERVICE TAXING UNIT, PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the Board of County Commissioners of Orange County, Florida did on April 25, 1983 adopt a Resolution establishing a municipal service taxing unit for aquatic weed control and general lake maintenance and improvements for Lake Maitland and Lake Minnehaha; and

WHEREAS, said taxing unit has been in operation for three fiscal years since its creation and has established a reserve for future maintenance of Lake Maitland and Minnehaha, and

WHEREAS, the Board of County Commissioners levied no millage within the unit for fiscal year 1985-86; and

WHEREAS, the Board of County Commissioners has determined that there does not exist a present need for the existence of the unit;

NOW THEREFORE BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF ORANGE COUNTY:

SECTION 1. That the Resolution which created the Lake Maitland-Minnehaha municipal service taxing unit is hereby repealed. The taxes which have been collected pursuant to the authority vested in the taxing unit shall be utilized by Orange County for the purposes of aquatic weed control in Lake Maitland and Lake Minnehaha. In the event the need for the taxing unit reoccurs then Orange County may recreate the taxing unit, subject to compliance with applicable legal notice and public hearing requirements.

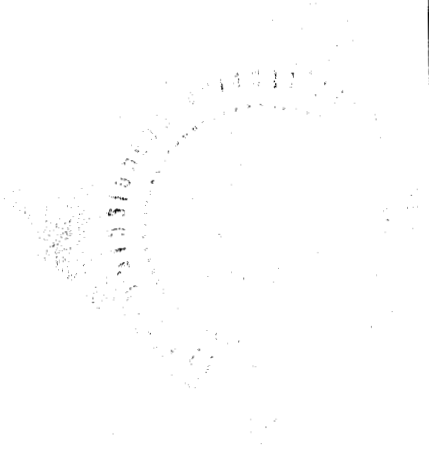
