A RESOLUTION CALLING A REFERENDUM TO BE HELD
IN ORANGE COUNTY, FLORIDA, ON A PROPOSITION
FOR THE ISSUANCE OF \$300,000,000.00 PARK
BONDS

WHEREAS, the Board of County Commissioners of Orange County deems it advisable at this time to submit the proposition hereinafter set out to a referendum on November 4, 1986, to be voted on by the qualified electors of Orange County; and

WHEREAS, no referendum has heretofore been held within Orange County on the question of issuing bonds for park purposes since prior to May 4, 1986;

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners of Orange County, Florida, as follows:

Section 1. A referendum is hereby called to be held throughout Orange County on November 4, 1986, in conjunction with and at the same times and polling places as the general election being held on that date. The proposition to be voted on at said referendum shall be that set out in the Notice of Referendum appearing in Section 3 hereof.

Section 2. The qualification and registration of electors participating in such referendum shall be same as prescribed for voting in other elections under Florida law. The officials responsible for the canvass of said general election shall also canvass the returns of the referendum and shall certify the same to the Board of County Commissioners of Orange County in accordance with Section 100.271 F.S.

Section 3. The County Administrator shall cause at least 30 days' notice of said referendum to be given by publication in The Orlando Sentinel, a newspaper of general circulation in Orange County. The publication shall be made at least twice, once in the fifth

week and once in the third week prior to the week in which the referendum is to be held. Said Notice of Referendum shall be in substantially the following form:

NOTICE OF REFERENDUM

Notice is hereby given that a referendum will be held in Orange County, Florida, on Tuesday, November 4, 1986, at the same times and places as the general election being held on said date. The following proposition shall be submitted at said election:

PROPOSITION

Proposition for the issuance of \$300,000,000.00 Park Bonds of Orange County to acquire and improve recreational and conservation lands in Orange County and to construct a zoo, said bonds to bear interest at the annual rate of twelve percent or less, paid from a tax to be levied on all property in said County subject to taxation to pay such bonds in an amount sufficient to pay principal and interest thereon when due.

If the foregoing proposition carries at said referendum, then it shall be the policy of Orange County to levy a one-half mill tax to pay the principal of and interest on the bonds specified in the foregoing Proposition and to acquire and improve recreational and conservation lands. Said levy shall not exceed one-half mill except if and when a greater tax is necessary to pay principal of and interest on said bonds.

Section 4. The Supervisor of Elections of Orange County shall present to all voters of Orange County at said referendum the proposition above set out. On the ballot title following Proposition shall appear the words "For bonds" and "Against bonds."

Section 5. If any section, clause or other part hereof shall ever be held to be illegal, invalid or ineffective, such section, clause or other part shall be deemed severable and the remainder shall continue in effect as if such section, clause or other part had not been included herein.


Section 6. This Resolution shall take immediate effect.
