RESOLUTION NO. 87-M-42

RESOLUTION AMENDING RESOLUTION 86-M-01;
REPLACING THE BIKEWAYS AD HOC COMMITTEE
WITH A PERMANENT STANDING BODY TO BE
KNOWN AS THE BIKEWAYS ADVISORY BOARD;
PROVIDING AN EFFECTIVE DATE.

WHEREAS, on January 6, 1986, the Board of County Commis-
sioners created the Bikeways Ad Hoc Committee for the purpose
of advising the Board concerning the implementation of the
1974 Orange County Bicycle Plan; and

WHEREAS, the Board, simultaneously with the passage of
this Resolution, has repealed the 1974 Bicycle Plan and, in
its stead, adopted the 1987 Orange County Bicycle Plan; and

WHEREAS, the Board acknowledges and agrees that the
implementation of the 1987 Bicycle Plan would be best
achieved through the assistance of a permanent standing body
charged with this purpose.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY
COMMISSIONERS OF ORANGE COUNTY, FLORIDA:

Section 1. Resolution 86-M-01 creating the Bikeways Ad
Hoc Committee is hereby amended to the extent that the Ad Hoc
Committee shall be a permanent standing body to be known as
the Bikeways Advisory Board.

Section 2. Sections 2 through 9 of Resolution 86-M-01
shall remain intact, and shall apply to the Bikeways Advisory
Board with the same force and effect as those sections pre-
viously applied to the now defunct Bikeways Ad Hoc Committee.

Section 3. All references in Resolution 86-M-01 to the
1974 Bicycle Plan are hereby amended to reflect the repeal of
the 1974 Bicycle Plan and the adoption of the 1987 Bicycle
Plan.

Section 4. Effective Date. This Resolution shall take
effect immediately upon its adoption.
