A RESOLUTION APPROVING A MINOR AMENDMENT TO
THE PREVIOUSLY APPROVED MAP OF RESERVATION
FOR APOPKA-VINELAND ROAD FROM SAND LAKE ROAD
TO CONROY-WINDERMERE ROAD.

WHEREAS, Section 336.02, Florida Statutes, as amended,
invests the commissioners of a county with the general
superintendence and control of county roads within its
county; and

WHEREAS, Section 336.02 authorizes the commissioners to
establish new roads and change or discontinue old roads; and

WHEREAS, consistent with these powers, Section 336.02
authorizes the commissioners to approve maps of reservation
for any road within the county's jurisdiction;

WHEREAS, Orange County Ordinance No. 84-21, as amended by
Ordinance No. 88-12, authorizes the County Commission to
approve maps of reservation by Resolution, and to amend such
maps;

WHEREAS, the original map of reservation for
Apopka-Vineland Road from Sand Lake Road to Conroy-Windermere
Road, was approved by the County Commission on May 16, 1988
by Resolution No. 88-M-26, and it is recorded in State and
County Road Reservation Map Book 1, Pages 40-45;

WHEREAS, an amendment to that original map of reservation
is proposed, and such amendment will affect less than five
percent (5%) of the total area within the original map; and

WHEREAS, the affected property owners have been notified
of this proposed amendment.

NOW, THEREFORE, BE IT HEREBY RESOLVED BY THE COUNTY
COMMISSION OF ORANGE COUNTY, FLORIDA:

1. The minor amendment to the original map of
reservation for Apopka-Vineland Road from Sand Lake Road to
Conroy-Windermere Road is approved. It is recorded in State
and County Road Reservation Map Book 1, Pages 79 through 84.

2. This Resolution shall become effective on the date
of its adoption.
