A RESOLUTION RENEWING THE PREVIOUSLY  
APPROVED MAP OF RESERVATION FOR  
APOPKA-VINELAND ROAD FROM STATE ROAD 50 TO  
A.D. MIMS ROAD.

WHEREAS, Section 336.02, Florida Statutes, as amended,  
invests the commissioners of a county with the general  
superintendence and control of county roads within its  
county; and

WHEREAS, Section 336.02 authorizes the commissioners to  
establish new roads and change or discontinue old roads; and

WHEREAS, consistent with these powers, Section 336.02  
authorizes the commissioners to approve maps of reservation  
for any road within the county's jurisdiction, to amend such  
maps, and to renew such maps; and

WHEREAS, Orange County Ordinance No. 84-21, as amended by  
Ordinance No. 88-12, authorizes the Board of County  
Commissioners to approve maps of reservation by Resolution,  
to amend such maps, and to renew such maps; and

WHEREAS, the original map of reservation for  
Apopka-Vineland Road from State Road 50 to A.D. Mims Road,  
was approved by the Board of County Commissioners by  
Ordinance No. 84-21; and

WHEREAS, the Board desires to renew and extend such map  
for an additional period of five (5) years; and

WHEREAS, the affected property owners have been notified  
of this proposed Resolution.

NOW, THEREFORE, BE IT HEREBY RESOLVED BY THE BOARD OF  
COUNTY COMMISSIONERS OF ORANGE COUNTY, FLORIDA:

1. The original map of reservation for Apopka-Vineland  
Road from State Road 50 to A.D. Mims Road is renewed and  
extended for an additional period of five (5) years. It is  
recorded in State and County Road Reservation Map Book 2,  
Pages 83/86.

2. This Resolution shall become effective on the date  
of its adoption.

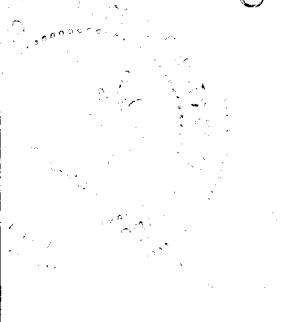
