RESOLUTION NO. 92-M-33

1 A RESOLUTION OF THE BOARD OF COUNTY
2 COMMISSIONERS OF ORANGE COUNTY, FLORIDA
3 ACCEPTING THE PROPOSED REAPPORTIONMENT
4 PLAN OF JULY 16, 1992 FOR THE ORLANDO
5 URBAN AREA METROPOLITAN PLANNING
6 ORGANIZATION; AUTHORIZING THE COUNTY
7 CHAIRMAN TO EXECUTE ALL NECESSARY
8 DOCUMENTATION TO IMPLEMENT THE PROPOSED
9 REAPPORTIONMENT PLAN; AND PROVIDING AN
10 EFFECTIVE DATE.

11 NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY
12 COMMISSIONERS OF ORANGE COUNTY, FLORIDA:

13 Section 1. The Board of County Commissioners of Orange
14 County, Florida accepts the proposed reapportionment plan for
15 the Orlando Urban Area Metropolitan Planning Organization
16 (MPO) as approved by the MPO at its meeting of July 16,
17 1992. A copy of reapportioned composition is attached hereto
18 and incorporated herein as Exhibit "A".

19 Section 2. The Board of County Commissioners of Orange
20 County, Florida hereby authorizes the County Chairman to
21 execute on behalf of the County all documentation as may be
22 necessary to implement the proposed reapportionment plan.
23 However, once the reapportioned composition of the MPO is
24 established, Orange County appointments to the MPO shall be
25 by vote of the Board of County Commissioners.

26 Section 3. As requested by the MPO Transportation
27 Planning Director a certified copy of this resolution shall
be forwarded to the MPO upon adoption for inclusion in the
MPO's report on the reapportionment plan to the Governor of
the State of Florida.

Section 4. Effective Date. This Resolution shall take effect immediately upon its adoption.

ORLANDO/ORANGE COUNTY EXPRESSWAY AUTHORITY: 1 representative appointed by the Governor per Florida Statutes

CENTRAL FLORIDA COMMUTER RAIL AUTHORITY: 1 representative per Florida Statutes

CITY OF ORLANDO: 2 representatives designated by the Orlando City Council

OTHER MUNICIPALITY IN ORANGE COUNTY: 1 representative designated as the next largest city based on University of Florida population estimates (currently Winter Park)

OTHER MUNICIPALITIES IN SEMINOLE COUNTY: 2 representatives designated as the (2) largest cities in the county based on University of Florida population estimates (currently Altamonte Springs and Sanford)

OTHER MUNICIPALITIES IN OSCEOLA COUNTY: 1 representative designated as the largest city based on University of Florida population estimates (currently Kissimmee)
