RESOLUTION NO. 94-M-40

A RESOLUTION AUTHORIZING THE CHAIRMAN OF ORANGE COUNTY TO EXECUTE A DEED CORRECTING CERTAIN TECHNICAL OVERSIGHTS FOUND IN THAT CERTAIN DEED CONVEYING LANDS TO THE BOARD OF TRUSTEES OF THE INTERNAL IMPROVEMENT TRUST FUND OF THE STATE OF FLORIDA FOR THE CREATION OF THE "WEST ORANGE TRAIL", SAID DEED HAVING BEEN AUTHORIZED BY RESOLUTION 94-M-14.

WHEREAS, the Board of County Commissioners of Orange County, by virtue of Resolution 94-M-14, authorized the Chairman of Orange County to execute a certain conveyance of lands to the Board of Trustee of the Internal Improvement Trust Fund of the State of Florida (Fund) for the purpose of permitting he State to assemble lands for a linear recreational trail known as the "West Orange Trail" in order that the State might lease said linear recreational trail to Orange County, and

WHEREAS, the Board of Trustees of the Internal Improvement Trust Fund of the State of Florida has received said deed as executed by virtue of the said Resolution 94-M-14 and the said Fund has notified Orange County that it is unable to accept and record said deed due to the presence therein of certain minor scrivener's errors and technical oversights, and

WHEREAS, the Real Estate Management Department has prepared a corrective deed to replace the aforementioned deed rejected by the Fund, and the Fund has inspected said corrective deed and found the same satisfactory in all respects, and the corrective deed does in fact convey precisely the same parcel of land as was to be conveyed under authority of Resolution 94-M-14, and a copy of said corrective deed is attached hereto as Exhibit "A",

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF ORANGE COUNTY, FLORIDA:

Section 1. That the Chairman of Orange County be and hereby is authorized to execute that corrective deed a copy of which is attached hereto as Exhibit "A".

Section 2. That a certified copy of this Resolution shall be forwarded to the proper authorities of the State of Florida.

Section 3. This Resolution shall become effective on the day of its adoption.
