RESOLUTION

of the
ORANGE COUNTY BOARD OF COUNTY COMMISSIONERS

adopting
**A REVISED FEE SCHEDULE FOR WASTE TIRE TIPPING
FEES AT COUNTY SOLID WASTE FACILITIES**

RESOLUTION NO. 98- M-20

1. The Board of County Commissioners (the "Board") is authorized to establish, operate and maintain a waste collection and disposal system within Orange County pursuant to its powers as a charter county, Florida law and Section 32-16 of the Orange County Code.
2. The Board is also authorized to prescribe, fix, establish and collect fees, rentals, or other charges for the facilities and services furnished by such waste collection and disposal system, or any part thereof.
3. Waste tires are received at the Orange County Landfill and currently are disposed of by a private contractor at a waste to energy facility.
4. Historically, calculation of the tipping fees for waste tires has been calculated in part based upon the number of tires received by Orange County for disposal.
5. Orange County has processed substantially more waste tires through its Solid Waste System this year to date.
6. The current waste tire tipping fee does not cover the actual combined costs of operation of Orange County's Waste Tire Program and processing of the waste tires received at Orange County Solid Waste Facilities.
7. The Utilities Division intends to conduct a rate study for waste tire tipping fees to be brought back to the Board for consideration.
8. Because of the increased number of waste tires received by Orange County, the depletion of the State of Florida Waste Tire grant and the need to fully fund the County's Waste Tire Program, the Board finds it necessary to increase the tipping fees for waste tires prior to completion of the rate study for waste tire tipping fees.

9. Notice of the public hearing to consider the increased tipping fees for waste tires has been published in *The Orlando Sentinel*.

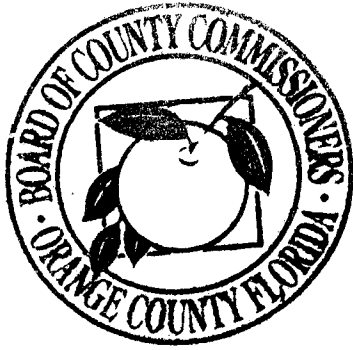
ACCORDINGLY, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF ORANGE COUNTY:

Section 1. Revised Tipping Fee Charge Schedule. The Board of County Commissioners hereby adopts the revised tipping fee schedule for waste tires attached hereto and incorporated in this Resolution as Exhibit "A". The attached schedule supersedes and hereby repeals the presently existing tipping fee schedule only and to the extent this Resolution applies to tipping fees for waste tires. The remaining portions of the existing Solid Waste Fee Schedule adopted December 13, 1994, in Resolution No. 94-SW-03 shall remain in full force and effect.

Section 2. Severability and Provisions. If any provision of this Resolution or the application thereof to any person or circumstance is held invalid, the invalidity shall not affect other provisions or applications of this Resolution which can be given effect without the invalid provision or application, and to this end the provision of this Resolution are declared severable.

Section 3. Effective Date. This Resolution shall take effect immediately upon its adoption.
