RESOLUTION AUTHORIZING SALE OF EASEMENT  
TO ORLANDO UTILITIES COMMISSION AND THE  
CITY OF ORLANDO.

WHEREAS, the Orlando Utilities Commissioner (OUC) and the City of Orlando (CITY), have made application to Orange County for grant of easement necessary for the installation of transmission lines; and

WHEREAS, the Board of County Commissioners of Orange County, Florida has determined that the grant of such easement will not interfere with Orange County's intended use of the property and is required by OUC and the CITY for the use requested; now, therefore,

BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF ORANGE COUNTY, FLORIDA:

Section 1. That the Chairman and Clerk to the Board shall be authorized to execute the grant of easement for the following described property:

THAT PART OF:

Sections 10 and 11, Township 23 South, Range 31 East, Orange County, Florida:

DESCRIBED AS FOLLOWS:

Beginning at the Southwest corner of the Northwest 1/4 of Section 10, Township 23 South, Range 31 East, Orange County, Florida, said point also being the Northwest corner of that certain Orlando Utilities Commission transmission line right-of-way described as Parcel 3 and recorded in Minute Book 16, Pages 83 through 85, Public Records of Orange County, Florida, run North 89 degrees 47 minutes 57 seconds East 10629.87 feet along the North boundary of said Orlando Utilities Commission right-of-way to the Southeast corner of the Northeast 1/4 of Section 11, Township 23 South, Range 31 East; thence run North 00 degrees 10 minutes 23 seconds East 23.00 feet along the East boundary of said Northeast 1/4 to a line parallel with and 23.00 feet North of, when measured at right angles to, the aforesaid North boundary of the Orlando Utilities Commission right-of-way; thence run South 89 degrees 47 minutes 57 seconds West 10629.98 feet to the West boundary of the aforesaid Northwest 1/4 of Section 10; thence run South 00 degrees 06 minutes 39 seconds East 23.00 feet to the Point of Beginning.

Section 2. That upon execution, said grant of easement shall be tendered to OUC and the CITY in exchange for payment of \$18,944.00 by check.

Section 3. This Resolution shall become effective upon adoption.
