2 **RESOLUTION GRANTING A TWO YEAR EXTENSION**
3 **TO DISPOSALL, INC., FOR RESIDENTIAL**
4 **GARBAGE COLLECTION IN ORANGE COUNTY**

5 WHEREAS, DISPOSALL, INC., is currently a licensed
6 franchisee by ORANGE COUNTY authorized to collect and
7 transport garbage generated by residences in certain areas of
8 Orange County; and

9 WHEREAS, said franchise is currently due to expire on
10 December 31, 1989; and

11 WHEREAS, DISPOSALL, INC., has made application to extend
12 its franchise for a two year period in accordance with
13 Section 15-47(g) of the Orange County Code; and

14 WHEREAS, ORANGE COUNTY has determined that based upon
15 its performance during the previous two years of its
16 franchise that DISPOSALL, INC., is qualified to fulfill a two
17 year extension to the franchise.

18 NOW, THEREFORE, BE IT RESOLVED BY THE ORANGE COUNTY
19 COMMISSION:

20 Section 1. That DISPOSALL, INC., is hereby granted a
21 two year extension to its current franchise to collect
22 residential waste in the area of Orange County described in
23 the legal description attached hereto as Exhibit "A" to this
24 Resolution. Said extension shall be for the period of
25 January 1, 1990 through December 31, 1991. The franchisee
26 shall elect by October 1, 1989 to either apply for a two year
27 extension for calendar years 1992 and 1993 or indicate by
28 certified mail that it shall not continue servicing its
29 residential area after December 31, 1991.

30 Section 2. This franchise shall be governed by all
31 applicable provisions of the Orange County Code either
32 currently in effect or as are amended from time to time by
33 the Orange County Commission.

For a Point of Beginning, commence at the Point of Intersection of S. R. 436 and Cady Way; thence run West along the centerline of Cady way to the Point of Intersection with Lakemont Avenue; thence run North along the centerline of Lakemont Avenue to the Point of Intersection with Aloma Avenue; thence run East along the centerline of Aloma Avenue to the Point of Intersection with Balfour Drive; thence run South along the centerline of Balfour Drive to the Point of Intersection with Abby Road; thence run East along the centerline of Abby Road to the Point of Intersection with Ranger Boulevard; thence run North along the centerline of Ranger Boulevard to the Point of Intersection with Aloma Avenue; thence run East along the centerline of Aloma Avenue to the Point of Intersection with Forsyth Road; thence run South along the centerline of Forsyth Road to the Point of Intersection with University Boulevard; thence run West along the centerline of University Boulevard to the Point of Intersection with S. R. 436; thence run South along the centerline of S. R. 436 to the Point of Intersection with Cady Way, also being the Point of Beginning.

Less that portion lying within any City limit boundary.
