A RESOLUTION OF THE CITY OF ORLANDO GRANTING  
CONCEPTUAL APPROVAL OF THE INTERLOCAL AGREEMENT  
WITH ORANGE COUNTY FOR SOLID WASTE MANAGEMENT AND  
AUTHORIZING ORANGE COUNTY TO APPLY TO THE FLORIDA  
DEPARTMENT OF ENVIRONMENTAL REGULATION FOR GRANT  
FUNDS ON THE CITY'S BEHALF.

WHEREAS, the Florida Legislature recently passed Senate  
Bill 1192 entitled, the "Florida Resource Recovery and  
Management Act", which requires the Florida Department of  
Environmental Regulation (FDER), in consultation with local  
governments, to develop and implement a State Solid Waste  
Management Program; and

WHEREAS, as part of the State Solid Waste Management  
Program, counties and municipalities are encouraged to form  
"cooperative arrangements" for implementing recycling  
programs; and

WHEREAS, Orange County and municipalities within its  
jurisdictional boundaries, including the City of Orlando,  
desire to enter into an Interlocal Agreement for Solid Waste  
Management; and

WHEREAS, the FDER has requested that all local  
governments entering into the Interlocal Agreement take  
action to conceptually approve the Agreement, and authorize  
the County to apply for grant money on behalf of all  
participants; and

1 WHEREAS, the City of Orlando wishes to approve the  
2 Agreement in concept only and also wishes to authorize the  
3 County to apply for grant money on the City's behalf.

4 NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF  
5 THE CITY OF ORLANDO, FLORIDA, AS FOLLOWS:

6 1. The City of Orlando hereby conceptually approves  
7 the Interlocal Agreement with Orange County for Solid Waste  
8 Management.

9 2. The City of Orlando hereby authorizes Orange County  
10 to apply for grant money on the City's behalf from the State  
11 of Florida Department of Environmental Regulation.

12 3. The Orlando City Clerk is hereby directed to send  
13 copies of this Resolution to the Department of Environmental  
14 Regulation and all other persons as directed by the Mayor  
15 and City Council.
