The Head Start Division requests Board approval of the six Meal Service Agreements between the School Board and Orange County, Florida. This agreement will allow the School Food Service to provide Head Start children with two-thirds of the daily nutritional requirements. Meals will be furnished by the School Board Food Service at the following six Head Start Centers: Aloma, Englewood, Grand Avenue, Maxey, Richmond Heights, and Tangelo Park.

The Florida Childcare Food Program funds in the amount of \$209,325.60 will be used to cover the cost of meals. The term of this agreement is from October 1, 2014 through September 30, 2015. The County Attorney's Office and Risk Management Division have reviewed this agreement for legality and compliance with County policy guidelines.
