The Orange County Sheriff's Office is requesting \$2,000 from the Law Enforcement Trust Fund for the following purpose:

Contribution:

Greater Orlando CARES Mentoring Movement – \$2,000. This charitable organization addresses and helps in the diversion of drug use and prevention, provides a safe neighborhood, and helps reduce crime and the desire to commit crimes in order to survive.

ACTION REQUESTED: Approval for the Orange County Sheriff's Office to spend \$2,000 from the Law Enforcement Trust Fund to provide eligible contribution to Greater Orlando CARES Mentoring Movement.

PLEASE NOTE: The Board voted to establish spending limits of 20% for this fund for contributions. At this point in the year, contributions represent 1% of the total expenditures; however, the restriction applies to total expenditures for the year, at year-end. The Sheriff's Office has stated that they monitor their expenditures, and that they will not exceed the 20% total for contributions.
