The EMS Office of the Medical Director requests the approval of the renewal Certificate of Public Convenience and Necessity for Reedy Creek Emergency Services. Reedy Creek Emergency Services has submitted the attached application requesting the renewal of their Certificate of Public Convenience and Necessity to provide Advanced Life Support Transport Service. The current Certificate has been in effect as an Advanced Life Support Transport Service since 1996, and formerly as an ALS Non-Transport since 1983.

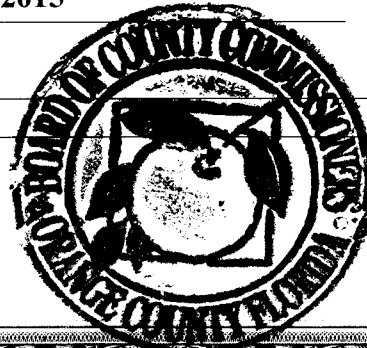
