

County Convention Center, Lot A

ACTION REQUESTED:

Approval to award Invitation for Bids Y14-629-DG, Portable Food Preparation and Point of Sale Carts for the Orange County Convention Center, Lot A, to the low responsible bidder, K2 Evolution LLC, in the total contract amount of \$693,800.

PROCUREMENT:

To provide thirty portable food preparation and point of sale carts to be used by the Orange County Convention Center contracted food service provider, Centerplate.

FUNDING:

Funding is available in account numbers 4430-035-0960-6410 and 4430-035-0960-4123.

APPROVALS:

The Business Development Division and Convention Center concur with this recommendation.

REMARKS:

Five bids were received in response to the solicitation. The bids were evaluated for price, responsiveness and responsibility. The bids from Corsair Display Systems/The Vollrath Co., Interior Contract Services and Ikoniq were not compliant with the specifications and were determined to be non-responsive. A protest was submitted by Ikoniq. The protest was denied by the manager of procurement and an appeal was not filed. The bid from K2 Evolution LLC is considered reasonable in comparison based upon the analysis by county technical personnel.
