A request to amend the existing 539.55-acre Hamlin Planned Development / Unified Neighborhood Plan (PD/UNP) by rezoning the subject property from PD (Planned Development District) and A-1 (Citrus Rural District) to PD (Planned Development District). More specifically, the request would extract Parcel CCM-5 (~37.13 acres) from the existing PD, and aggregate / rezone SAP Parcel CCM-7 (~38.0 acres) and an adjacent Upland Greenbelt tract (1.93-acres) from A-1 to PD. The request would also reduce existing PD development entitlements by 57 residential dwelling units, three (3) residential bonus units; 205,800 sq. ft. of non-residential uses, and one (1) hotel room.

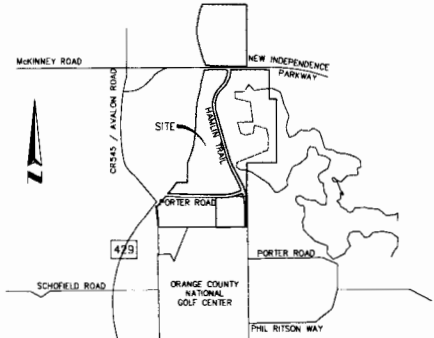

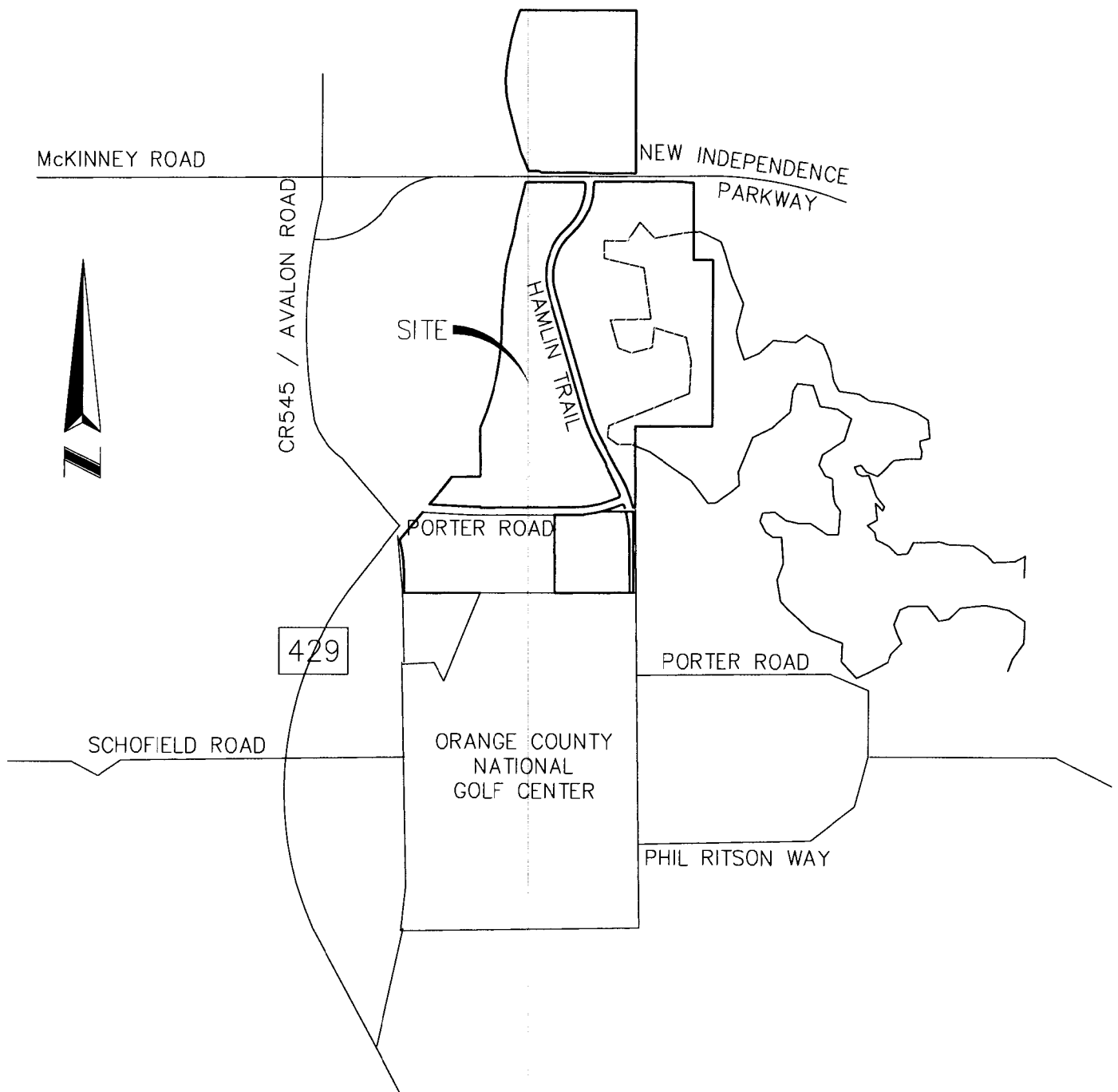
