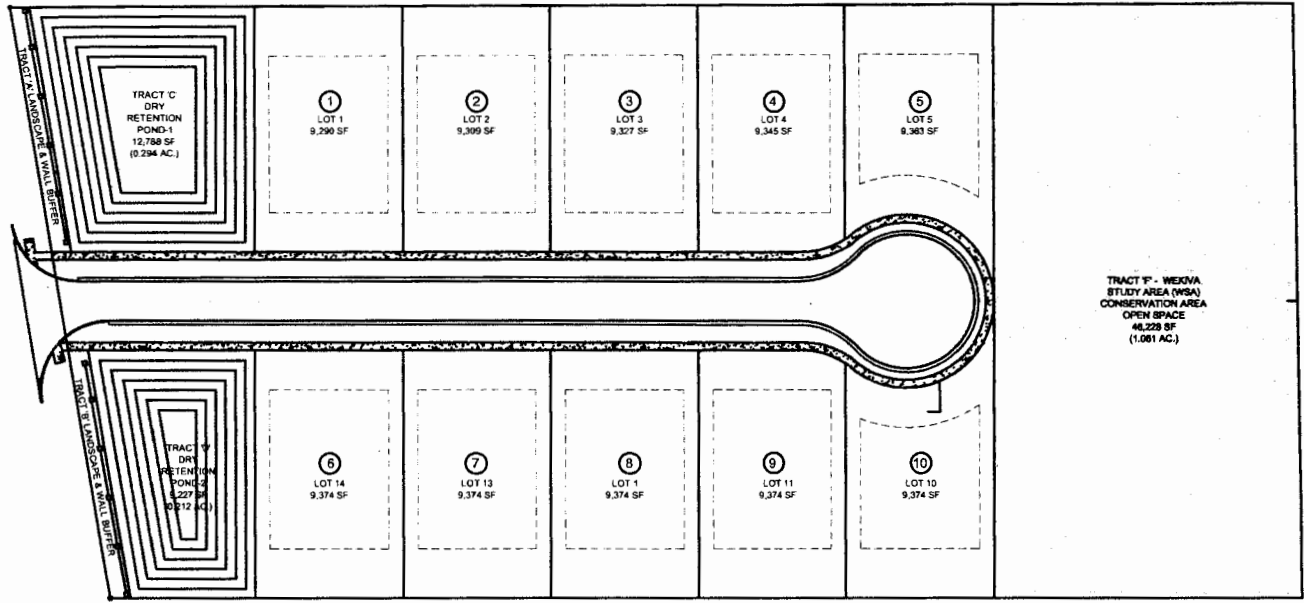
LOCATION MAP

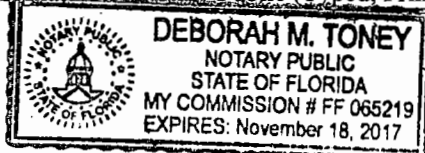
