SUBJ: **Establishing a Designated “No Truck or Tractor Trailer Parking” Zone for FHWA Vehicle Classifications 6 through 13 on Avalon Park Boulevard Northbound and Southbound between Tanja King Boulevard Golden Rain Tree Boulevard**

The Avalon Park Group are requesting that a designated “No Truck or Tractor Trailer Parking” zone for Federal Highway Administration (FHWA) vehicle classifications 6 through 13 is established on Avalon Park Boulevard northbound and southbound between Tanja King Boulevard and Golden Rain Tree Boulevard in east Orange County.

The Traffic Engineering Division was contacted by the Avalon Park Group regarding a history of on-street parking of 18-wheelers on Avalon Park Boulevard. These vehicles are owned by residents in the area.

Orange County Code Enforcement Division inspected a recent complaint on Saturday 8-22-15 and observed 1 white box truck, 1 semi with the trailer and 1 trailer all parked along S Avalon Park Boulevard. The code enforcement officers were able to locate the owner of the white box truck and issued him a citation warning. The other vehicles were tagged. The parking of these types of vehicles along Avalon Park East Boulevard is a safety issue and creates an unsafe line of sight for motorist and pedestrians as they are not able to see oncoming traffic.

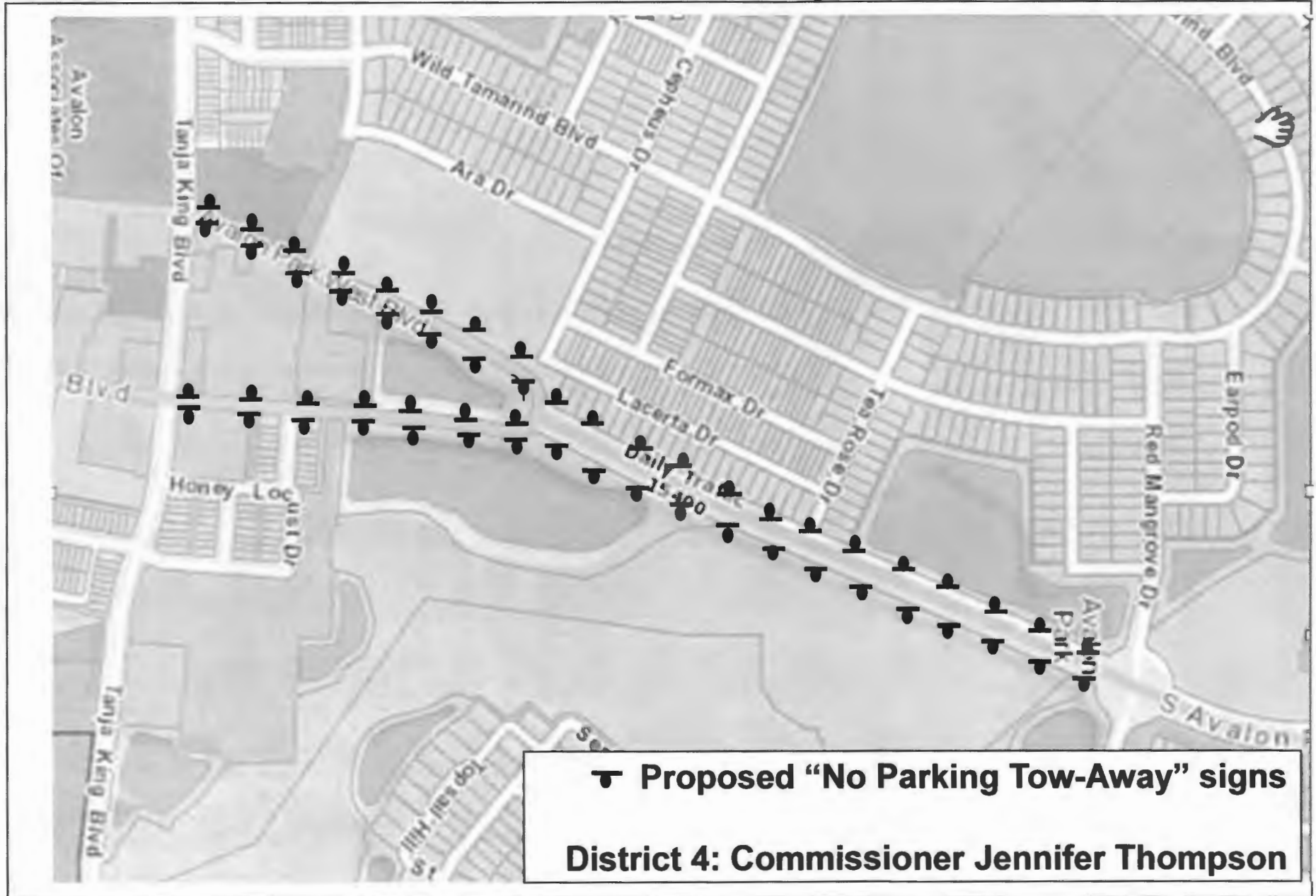
Staff recommends that the Board approve the establishment of a designated “No truck or tractor trailer parking zone for FHWA vehicle classifications 6 through 13 on Avalon Park Boulevard northbound and southbound between Tanja King Boulevard and Golden Rain Tree Boulevard.

Action Requested: Approval of Resolution of the Orange County Board of County Commissioners regarding establishing a “No Truck or Tractor Trailer Parking” zone for FHWA Vehicle Classifications 6 through 13 and a “No Parking Tow Away” zone for those same vehicle classifications on Avalon Park Boulevard northbound and southbound between Tanja King Boulevard and Golden Rain Tree Boulevard.
