II, Sec. 8(f)(1), effective 12/31/2022 , a public officer includes "a statewide elected officer, member of legislature, county commissioner, county officer under Const. or charter, school board member, a superintendent of schools, an elected municipal officer, an elected special district officer, or person serving as secretary, executive direct or other agency head of the executive branch of the state government." However, under Fla. Stat. sec. 112.313(a), a public officer "includes any person elected or appointed to hold office in any agency, including any person serving on an advisory body. "
