

TOURIST DEVELOPMENT TAX COLLECTIONS ORANGE COUNTY, FLORIDA

ORLANDO, FLORIDA – Orange County Comptroller Phil Diamond announced today that Tourist development tax collections received by Orange County for the January 2021 TDT collection month were \$7,678,100. That is a 70% decrease from January 2020.

Unfortunately, this is the first month-over-month decline in TDT collections since hitting rock bottom in April 2020. This amount is less than we have collected in any pre-pandemic month since September 2004. It's also less than we have collected in any January since 2002. In short, TDT collections are still at historic low levels as shown in the chart below.

While January's results were disappointing, they were not completely unexpected due to the significant surge in COVID-19 cases locally and at the national level. Also, compared to last January, the VRBO Citrus Bowl was played with limited audience capacity, and the Pro Bowl was not played here in 2021.

While we still face many challenges in the short-term, there are reasons to be optimistic for the long-term outlook. Millions of people have already received vaccines, and the supply and pace of vaccinations continue to increase. Recently, the President announced there will be enough supply to vaccinate every adult by the end of May – two months earlier than initially anticipated. And, there has already been very encouraging data and outcomes from populations that have already received the vaccine. Also, Universal's decision to resume construction of its new theme park, Epic Universe, shows that the business community has confidence and optimism about Orange County's long-term economy. These are all positive and hopeful signs that we may be getting closer to turning the corner in the pandemic.

On the expenditure side, the County continues to use TDT reserves to offset ongoing TDT collections shortfalls and meet funding obligations. The County has used \$128.3 million in reserves since April. For the month of January, reserves decreased by \$25.2 million as shown in the attached "TDT Cash Reserve Summary". The majority of the reserve drawdown was used to cover the remaining \$15 million balance for the Camping World Stadium renovations.

Finally, we will release the February TDT collections report in early April.

- 2. The County has committed to maintaining a reserve for property replacement equal to 4% of the Convention Center's gross physical plant and equipment-excluding construction in progress. This Renewal and Replacement Reserve component is currently fully funded at \$61,642,501.
