

## TOURIST DEVELOPMENT TAX COLLECTIONS ORANGE COUNTY, FLORIDA

ORLANDO, FLORIDA – Orange County Comptroller Phil Diamond announced today that Tourist Development Tax (TDT) collections received by Orange County for the March 2022 TDT collection month were \$38,568,500. That is a 118.2% increase over March 2021.

Month-over-month, March collections were higher than February collections by \$10.2 million and were higher than March 2020 collections by \$24.7 million. Most notably, however, these were the highest monthly collections ever, shattering the previous high set in March 2019 by \$7.3 million or 23%! The chart below shows monthly TDT collections for the current fiscal year and the previous two fiscal years.

Orlando's March hotel occupancy rate of 82.5% was higher than February's rate of 73.7%, and the average daily rate (ADR) reached a new high of \$173 (Source: Visit Orlando). On the TDT reserve side, there was a \$5.3 million increase in the Renewal and Replacement Reserve in March as shown in the attached "TDT Cash Reserve Summary". On a cumulative basis, since the start of the pandemic, the County has used \$118.3 million of reserves to meet its TDT obligations. That has caused our undesignated "Other Authorized Uses" reserves to decrease from \$181.3 million to \$63.0 million during that time.

We will release the April TDT collections report in early June.

- 1. Debt service reserves are restricted for debt service only and equal the maximum annual debt service payment.
- 2. The County has committed to maintaining a reserve for property replacement equal to 4% of the Convention Center's gross physical plant and equipment-excluding construction in progress. This Renewal and Replacement Reserve component is currently fully funded at \$63,155,846.
